### **Record Turnout for MSCHE Annual Conference**

The 2016 MSCHE Annual Conference, held December 7-9 in Philadelphia was a rousing success. Nearly 1400 people attended, making it the largest conference in the Commission's 97-year history.

The four plenary sessions examined topics of great importance to higher education leaders in the Middle States region. Mary E. Kennard, Vice President and General Counsel at American University, addressed *The Impact of Federal Regulation on Higher Education Institutional Culture, Diversity, and Leadership.* Lynne Schaefer, Vice President for Finance and Administration at the University of Maryland, Baltimore County, spoke on *The CFO's Perspective: Issues and Trends That Will Affect Higher Education.* Robert Clark, MSCHE Commissioner and Chair of the MSCHE Steering Committee on Process Review, provided a final update on the proposed process and cycle changes that are being presented to the chief executive officers of MSCHE institutions for their approval. Patricia McGuire, President of Trinity Washington University, discussed *New Administration but Old Higher Education Challenges.*

## **Commission Adds New Staff**

The Commission has recently added the following new staff positions.

Christian R. Slater is the new Senior Support Specialist, providing technical support to MSCHE Commissioners, staff, and member institutions on matters related to accreditation. He will also conduct in-house training and staff the IT help desk. Mr. Slater began his MSCHE duties in late November. Prior to joining the MSCHE staff he was employed for 5-1/2 years by Villanova University, where he provided executive-level IT support.

Also recently hired was W. Allen Richman, who will begin in January 2017 as the Commission's new Senior Director for Research. Dr. Richman comes to the Commission from Prince George's Community College, where he served in a variety of roles, most recently as Interim Dean, Office of Planning, Assessment, and Institutional Research.

Once Dr. Richman joins the Commission, a search will begin to fill the position of Research Analyst. Additional details will be available in mid-January 2017.

# Puerto Rico Institutions Are Considered 'U.S. - Based'

The Commission has received an increasing number of reports from students who previously attended MSCHE institutions in Puerto Rico that colleges and universities on the mainland United States have told them that before transferring, the students must have their credits evaluated because they had attended "international" institutions.

Puerto Rico is a Commonwealth of the United States, and the U.S. Department of Education considers all accredited Puerto Rico colleges and universities to be U.S. – based. Thus, the Commission's view is that students' credits that were earned in Puerto Rico do not need to be evaluated as if they had been earned at foreign-based institutions.

## **Recent Commission Actions**

The Commission held its most recent meeting on November 17 in Philadelphia. During the meeting the Commission took 117 actions. The Commission reaffirmed the accreditation of 68 institutions, granted Candidacy status to two institutions, deferred Candidacy for one other, placed two institutions on warning, and approved two complex substantive changes.

The two institutions granted Candidacy status are Daniel Morgan Academy, soon to be renamed Daniel Morgan Graduate School of National Security, and Johnson College.
