## Meeting of the Hunter College Senate

### 29 November 2017

1                   The 606<sup>th</sup> meeting of the Hunter College Senate convened at 3:39 PM in HW room 714.

13 **Report by**  
14 **the President:**       **President Raab said the following:**  
15

16                   Thank you so much, Tom. I, along with the Hunter community, celebrate our first Rhodes Scholar.  
17                   It is extraordinary. Thamara Jean is an incredible young woman, but her award also reflects how  
18                   much the faculty at Hunter College do for our student body. I want to take a minute to say thank  
19                   you to all of you. In reading her application, we saw so many different touches by faculty, Student  
20                   Services, mentors, and people providing assistance in the school. In essence, it really takes a  
21                   village.

23                   When Thamara started as a Macaulay Honors scholar at Hunter College, she had a lot of support.  
24                   When she joined Professor Somerville's class in Political Science, it was the first time she ever  
25                   even thought of this idea that she could get a doctorate; that she could take this love of learning and  
26                   turn it into scholarship and a career, both as an activist and a scholar. When you read about  
27                   Professor Somerville's reaction and recommendation for Thamara, and you hear this young woman  
28                   talk about the guidance of her faculty members, it really is beautiful. She is a Media Studies major  
29                   and talks about faculty in that department engaging her and teaching her about the impact of the  
30                   media. She did a very special program at Roosevelt House, where she was assigned to a project to  
31                   help pass the ERA and she talks about how her thinking about African American politics and  
32                   political theory expanded into gender studies for the first time. You can really see her growth  
33                   through that experience at Roosevelt House.

35                   And then, of course, Dr. Lassonde who joined us recently, went as far as to set up a mock-cocktail  
36                   party for her so that she was prepared for her Rhodes interviews. It does take a village and I am so  
37                   grateful to all of you for everything you do for our students. A moment like this is an opportunity to  
38                   celebrate everyone's contributions. When you find that wonderful young person and you see that  
39                   talent, please send them to our different advising centers. Let any of us know that you see  
40                   wonderful talent because it is our institutional commitment to support these extraordinarily talented  
41                   young people at Hunter who often so not get the attention that the Ivy League schools are set up to  
42                   provide. We are now really set up to provide the attention and support to these students. Please  
43                   make sure that we are nurturing them and helping them benefit from these incredible opportunities.

45                   I wanted to report on some of the search committees that are ongoing. From the Senate search in the  
46                   School of Social Work, the committee has decided on three or four finalists who will be visiting and  
47                   moving towards the conclusion of the process. We hope to see an appointment sometime in the  
48                   beginning of the year. I would also like to thank all of you in electing a search committee for the  
49                   Provost. We have a search consultant. That job is posted and that committee is charged, so that  
50                   process is moving along. Yesterday, I was privileged to charge a very diverse committee of faculty  
51                   from a number of schools and departments to find a new Director of the Human Rights Program.

55 We are moving along in all these areas and will report back as progress is made. Both the Social  
 56 Work and Provost searches have open sessions and opportunities to see candidates. I hope you all  
 57 find time to participate because your feedback is really, really essential.  
 58

59 On a bit of a less happy note, I would like to ask that at some point, perhaps at the beginning of next  
 60 semester, we have a presentation prepared on safety measures in emergency situations on campus,  
 61 particularly the hopefully-never-encountered situation of having an active shooter on campus. It is a  
 62 very sobering subject, but I think we all understand that this type of incident has occurred on  
 63 college campuses throughout the country. We have asked our excellent security team to prepare  
 64 protocol so that we all know what to do in that type of emergency situation. We have also been  
 65 investing resources in our public address system. All classrooms now have locks and shades so that  
 66 they can be blacked out. We would like to come back, maybe near the end of January or beginning  
 67 of February, to make a presentation to the community about the protocol, so that as many faculty  
 68 and students as possible have a sense of what procedures to follow in an event that we hope we  
 69 never see here. Thank you.

**Statement of Institutional Learning Outcomes**

We expect Hunter graduates to look outward and through ethical leadership to make a difference in their communities and in the world. A Hunter College education promotes personal development and self-awareness; it also fosters life-long learning and equips each student with the habits of mind, character, and confidence to embody our motto: The Care of the Future is Mine.

Through engagement with the institution, both In and out of the classroom, Hunter College expects its graduates to develop the following knowledge, skills, and values:\*

### Acquire Broad and Specialized Knowledge

Hunter graduates will have the breadth of knowledge to make a positive difference in a complex, diverse, and changing world.

- Develop a broad knowledge of the arts and humanities, social sciences, and natural sciences through completion of the program in General Education.
- Acquire an in-depth understanding of a major discipline or of a well-defined interdisciplinary area.

### Research and Communicate Effectively

Hunter graduates will learn to communicate with clarity, coherence, and purpose. They will access information and integrate a variety of sources to frame original arguments.

- Gather, analyze, evaluate, and effectively use information in pursuit of discovery, as preparation for life-long learning.
