## APPENDIX II

President Wexler reported to the Senate that we have the first tentative firm figures of the Chancellor's allocation. These figures indicate that we will not have to implement any of the tentative major surgery plans that have been proposed. The Chancellor's allocation includes \$4 million in the original budget and \$5 million appropriated for the senior colleges in the regular session of the legislature. The technical corrections with regard to leases and to the money left over in lines that were done away with last year have also been made.

The President congratulated Beaujour Committee of the Senate for "having the courage to deal with authority in a legislative function." The members of the Committee were praised clearly and specifically on procedure — without direct comment on the substance — of their proposals. Mrs. Wexler emphasized that she did not want to seem to be taking sides on the substance of the proposals. As we move toward a more and more distributive authority, real authority, it is the responsibility of such a body to offer proposals for intelligent consideration. In no way were these proposals hard fact or more than tentative. The Senate should always debate the curriculum and the academic programs of Hunter College. This is its legislative function and, even in stable or better times, it is the authority and the responsibility of this body to consider the most educationally sound program offerings and, within that, the best possible use of the resources for those academic programs.

President Wexler spoke about the recommendations of the Faculty, Personnel and Budget Committee and the Faculty Crisis Committee with regard to the administrative structure of the College. These recommendations were carefully reviewed with an eye toward the best possible use of resources and the desire to cut some significant substantial part of administrative services in order to redistribute it in other ways. The administration also took into account the best advice from all serious groups, including the Evening Session Council and the Professional Staff Congress Chapter. The first step solution was presented in a letter to the entire community which was mailed last week. A net administrative cut in excess of \$200,000, will be realized in addition to the transfer of a number of the functions which have been under the category of the administration to student services.

President Wexler then discussed the oral report of the Middle States Evaluation Team. The oral report was most positive on the substance of the faculty, on the substance of the programs, even on the general morale of the people in this institution under extreme exigency.

The Middle States Team counseled us on general student services, on services to the faculty, and on need for supporting systems that will validate into the future the case for supporting this College. We were exhorted to exert more energy and to commit more funds to the areas of recruitment, admissions, and advising. Those areas are the target of our concentration in the new administration arrangement. It is the intention of the Middle States Team that the Report and the President's response to it be documents for further discussion in community and not public relations documents. We shall make copies available and accessible by placing a representative number of copies in the most convenient places.

President Wexler concluded with the optimistic observation that most experts agree that the bond market is becoming more favorable. She announced a meeting with the State Dormitory Authority to determine the timing and strategy of getting the bonds — and our buildings — back on the track. "If we can get these buildings back on the line before the completion of this calendar year, if we can enter next year without any radical surgery to our institution, with the careful use of non-tax-levy monies we have been able to husband in our usual way of preserving unused monies from year to year, it is my cautious conviction and commitment that we will enter next year planning how to move forward rather than how to hold on."
